"DEWALT TOUGH TOGETHER" PROMOTION

TERMS AND CONDITIONS

- 1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
- 2. Entry is only open to Australian and New Zealand residents aged 18 years or over who can travel to Las Vegas, USA from 17/11/2023 until 20/11/2023.
- 3. Employees (and their immediate families) of the Promoter, Participating Stores (defined below) and agencies associated with this promotion are ineligible to enter.
