

## “WORK HARD PLAY HARDER 2020” PROMOTION

### TERMS AND CONDITIONS

1. Information on how to enter and the prize form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The promoter is Stanley Black & Decker Australia Pty Ltd (ABN 82 000 021 938) of Level 2, 810 Whitehorse Road, Box Hill, Victoria 3128 (Australia) and Stanley Black & Decker Inc. of 39 Business Parade North, East Tamaki, Auckland 2013 (New Zealand) (“**Promoter**”).
3. Entry is open to Australian and New Zealand residents only aged 18 years or over.
4. Directors, officers, management, employees and contractors (and the immediate families of directors, officers, management, employees, suppliers and contractors) of the Promoter and of its related bodies corporate and the agencies and companies associated with this promotion, are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin.

6. To be eligible to enter individuals must purchase any DEWALT product, from any DEWALT authorised stockist retailer in Australia or New Zealand during the Purchase Period (“**Qualifying Transaction**”). For every dollar (including GST) spent on DEWALT products the entrant will be eligible to receive one (1) entry into the draw. For example, if an eligible individual is to spend \$24 (including GST) on DEWALT products during the Purchase Period, they will be eligible to receive twenty-four (24) entries into the draw.
7. For the removal of doubt, purchases of a DEWALT product from a retailer that not is a DEWALT authorised stockist retailer (e.g. eBay, Amazon) are not eligible for entry into the promotion.

17. The NZD value has been calculated as of the daily exchange rate on 28/04/2020. Prize value includes 12 months registration, compulsory third party insurance, stamp duty and dealer delivery charges (which may vary). Additional insurance, options, petrol and all other ancillary

costs are the responsibility of the winner.
